

## **NOTICE ON THE APPLICATION OF THE CONSUMER'S RIGHT TO WITHDRAW FROM THE CONTRACT**

### 1. Right of withdrawal

You have the right to withdraw from the contract of sale for the purchase of the voucher, without giving a reason within 14 days.

The withdrawal period expires after 14 days from the date of the conclusion of the contract (i. e. from the date of delivery of the voucher)

When exercising your right of withdrawal, please let us know your decision to withdraw from this contract by an unambiguous statement (for example, by post, fax or e-mail) at MADWIRE, s. r. o. , Šoltésovej 14, 811 08 Bratislava, phone number: +421 2 577 85 500, e-mail address: [info@predpredaj.sk](mailto:info@predpredaj.sk)

If you are interested, you can fill in and send a sample withdrawal template or any other unambiguous withdrawal notice also electronically via our website [predpredaj.sk](http://predpredaj.sk). If you make use of this option, we will promptly confirm our acceptance of your withdrawal on a durable medium (e-mail, for example).

To do this, you can use the template to withdraw from the contract, which is published on the website [predpredaj.sk](http://predpredaj.sk).

The withdrawal period is retained if you send a notice of the exercise of the right of withdrawal before the expiry of the withdrawal period.

### 2. Consequences of withdrawal

Upon withdrawal, we will refund all payments you have made in connection with the conclusion of the contract, in

particular the purchase price, including the cost of delivering the goods to you. This does not apply to

additional costs if you have chosen a different kind of delivery, such as the cheapest common delivery method we offer. Payments will be refunded to you without undue delay, no later than 14 days after we receive your notice of withdrawal from this contract. Their payment will be made in the same way you used for your payment if you explicitly disagreed with any other payment method, without charging any additional costs.

If you have requested to start providing a service during the withdrawal period, you have the obligation to pay us the price for the services actually provided until the day you have notified us of your decision to withdraw from this contract.
